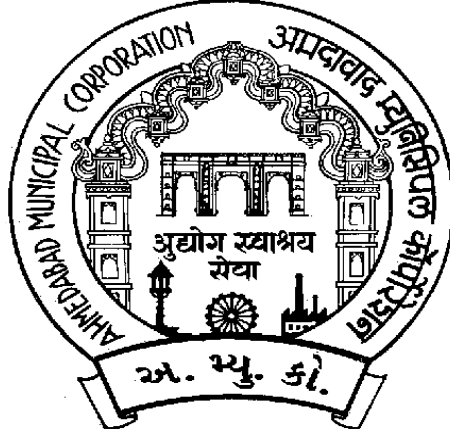

# Introduction

## 1. Project Background

### **Kids City : (Theme to be proposed by participants)**

Kankaria Lake has a unique identity in Ahmedabad. The historic lake around Naginawadi has been an evergreen outing place for the people of Ahmedabad. As a result of the redevelopment of Kankaria Lake Front, a city-level spot was converted into a state-level recreational zone through a planned approach, despite many challenges.

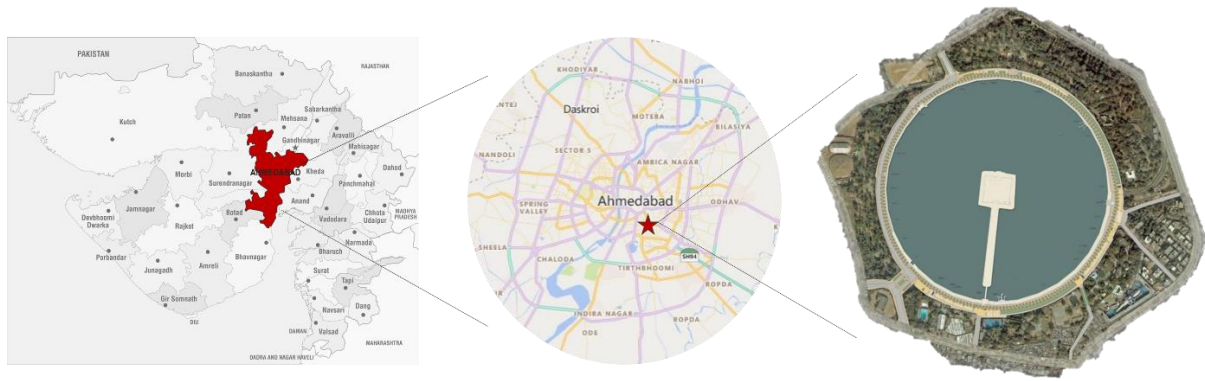
Kankaria Lake Front provides opportunities to launch city-level and state-level events that bring participation from all communities and strata. Its development with facilities like Atal & Swarnim Jayanti Express-Mini Trains, **Kids City**, Amusement Parks, Segway Safari, Adventure Tree Walk, Aqua Carting, Aquarium, Multi Colour Laser Shows with Musical Fountains, Food Courts, Walkways, Linear Gardens & Landscapes has added new charms for the visitors. Adjoining Zoo, Nocturnal Zoo, Butterfly Park, and Balvatika offer it as a complete entertainment center.

**Kids' City** is a miniature world designed for kids between the ages of 5 to 14. It is their own little mini-city where they can get the best of education as well as entertainment at the same time. It is a replica of a city with roads, vehicles, and a whole lot of activities like a bank, fire station, science lab, radio station, police station, courtroom, prison, dental as well as medical hospital, theatre, BRTS, heritage gallery, town governance, IT center, Newsroom, ice-cream factory, etc.

Parents can register and leave their kids in Kids' City under the guidance of Supervisors for as long as 3 hours per batch or 9 hours in a day. It is a very educative, extremely exciting, exceptionally interactive, and totally safe service that is now available for the first time in India.

In the simulated buildings, kids also get uniforms and equipment to play the role of various occupations that adults have like doctors, RJs, firefighters, and manufacturers, just as in real life. In addition, the VirMos (currency of Kids' City) helps the kids learn the true worth of money and also get to know the art of spending wisely and saving money for better things. Unlike theoretical knowledge, the highly practical experience that Kids' City offers is much more effective and the best part is that kids never get bored of it.

As the Kids City was developed in 2011 and it's been more than 12 years of operation of the same. The popular activities have become obsolete/outdated. Thus this EOI aims at modernisation and Upgradation of Kids City with new activities.



## **2. Purpose of Inviting EOI**

Ahmedabad Municipal Corporation, Ahmedabad, Gujarat is desirous to upgrade and modernise kids city with new activities and operate the same on a PPP basis. Under this format, the private sector shall be responsible for the modernization and upgradation of Kids City and for operations and maintenance of the same for a limited period of 10 years (may extend by 5 years, at the sole discretion of the authority).

The term applicant/bidder/service provider/operator used in the EOI document would therefore apply to whom so ever is applying to this EOI.

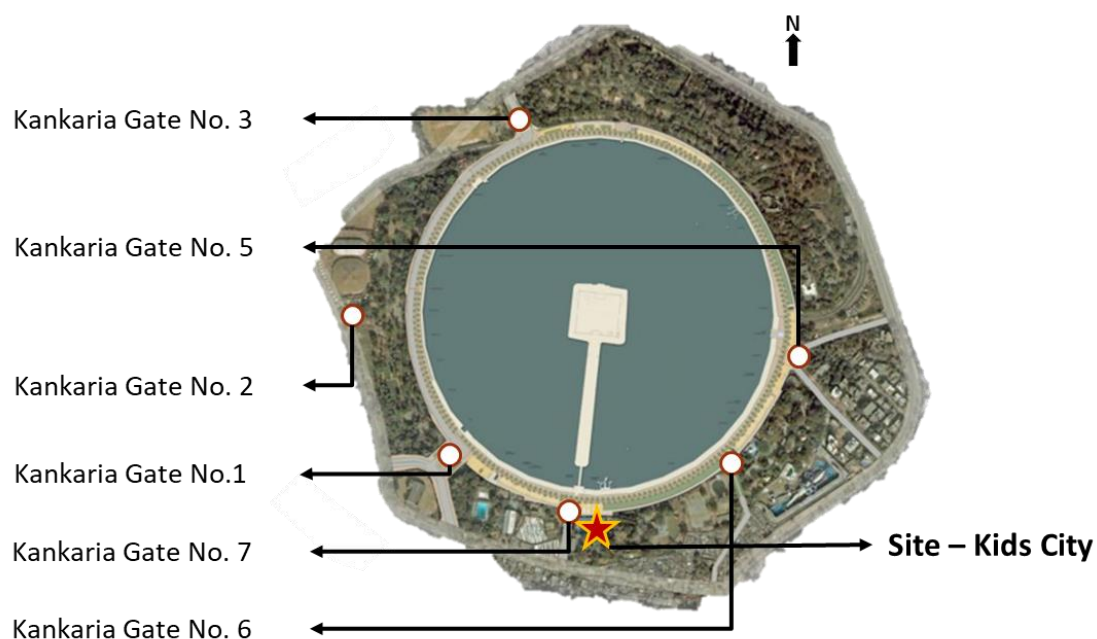
Further to this the Kids City premises have open vacant areas as shown below which and also be used for developing new outdoor activities in a similar learning or physical activity theme. Yellow marked spaces in the below image is the addition area for development of new activities (**Outside Building Activities- OBA**);



AMC is on the vision that by adding new activities and upgrading the existing Kids City, more attractions can be created in Kankaria and an effective learning opportunity can also be provided to children of all ages. Bidder is also open to take the project under green building design by adding solar panels, viability of the same to be checked by bidder.

#### 4. Site Location

The site is situated next to Gate no 7 of Kankaria Lake Front and have entry and exit from inside the Kankaria lake front and abutting parking.

## **6. General Instruction to Bidders**

- A. The cost of Bid document i.e. EOI fees will not be refunded under any circumstances.
- B. Language of the bid shall be English only.
- C. The Bidder should provide the details of activities and concept to the authority, with the sharing criteria under PPP.
- D. Bidders are advised to visit the site to study the actual working conditions, before submitting the EOI.
- E. Bidders shall submit necessary registration certificates any other if required for the execution of such work as per government rules along with the tender document.
  - a. If required bidders may visit Kankaria Lake Front Department, Vyamshala Gate no. 3, Maninagar, Ahmedabad for further clarification.
- F. Conditional EOI shall not be accepted. Authority reserves the right to accept or reject such EOIs without assigning any reason thereof.
- G. In case of any dispute or difference of opinion in the interpretation of any of the terms and conditions of this EOI, the decision of the Municipal Commissioner, shall be final and binding to all.
- H. The bidder is also eligible to use the advertisement rights for the Kids City as well rights to advertise any third party adds with proper due diligence of the advertisement, with the sole responsibility of bidder, authority in any case cannot be held responsible.
- I. If the EOI is cancelled no cost will be paid in any circumstances.
- J. The courts at Ahmedabad in Gujarat state only will have jurisdiction to deal with and decide any legal dispute or contravention between the parties hereto.

## Evaluation Criteria

- a. The Applicants' competence and capability is proposed to be evaluated by the following parameters.
  - Financial Capability in terms of Net-Worth & Annual Turnover and
  - Technical Capability of the Applicant.
- b. On each of these parameters, the Applicant would be required to meet the evaluation criteria as detailed in this section.
- c. The Applicant fulfilling the following conditions will be eligible to apply for this EOI
- d. Applicant is open to submit EOI for Kids as mentioned in previous section of this document.

### 7. Financial Capacity

#### EOI submitting for Kids City and Surrounding;

- The Bidder must have annual audited average turnover of at least INR 1,50,00,000/- (One Crore Fifty lakhs) from similar activities (includes any amusement activity in Learning by Doing Model/entertainment facilities not including theatre, movie hall etc.) from FY 2019-24.

The Applicant should submit the proof of annual audited turnover of last five financial years (FY 2019-20, 2020-21, 2021-22, 2022-23, 2023-24)

*Note: In consideration of Covid-19 pandemic, the turnover of FY 2020-21 will not be considered, though needs to be submitted.*

And

- The Applicant should have a Net worth of at least INR 2,50,00,000/- (Two Crore Fifty lakhs) as on 31<sup>st</sup> March 2024.

The applicant should submit the proof of net worth as on 31<sup>st</sup> March 2024.

### 8. Technical Capacity

The Applicant should have the following minimum experience mentioned below:

#### EOI submitting for Kids City and Surrounding;

- i. Minimum 2 –similar projects/ Entertainment facility with proof of construction and operation contract to be provided in the past three years from the date of issue of this EOI.  
and
- ii. As part of Technical Capacity, applicants are expected to make a presentation to the authority based on the concept note submitted.

### 9. Shortlisting of the Applicants & Issue of RFP

- The applicants meeting the requirements as detailed above, including the presentation made to the satisfaction of the authority shall be shortlisted for further selection process. The authority reserves the right to disqualify any bidder at this stage, if the presentations made is not as per the expectation of the Authority.

- The Request for Proposal (RFP) document will be limited to the applicants filling the EOI (Closed Bid). If as per authority opinion none of the submitted EOI is upto the mark, Authority reserves the right to open tender.
- Minimum two (2) EOIs shall be received for issue of the RFP.
- AMC reserves the right to reject any or all EOIs received without assigning any reasons thereof.

## Preparation & Submission of EOI

### 10. General

The Applicant to be a single entity, (JV/ Consortium not allowed), expressing interest for the Project. The Applicants eligible for participating in the EOI process shall be any of the following categories:

The Applicant shall be legally competent to enter into agreement as per prevailing Indian law and must be either:

- (i) A registered proprietary firm (Copy of GST registration, EPF registration, shop registration certificate, as may be applicable, should be submitted).  
Or
- (ii) Partnership firm registered the Indian Partnership Act (copy of registered partnership deed should be submitted)  
Or
- (iii) Limited liability partnership duly incorporated under the Limited Liability Partnership Act, 2008 (copy of registered partnership deed should be submitted)  
Or
- (iv) A company incorporated under the Companies act 1956 (as amended or re-enacted and restated including the Companies act 2013 as notified from time to time), (Copy of certificate of incorporation, Memorandum and Article of the Association of the Applicant should be submitted)

The term applicant/bidder/service provider/operator used in the EOI document would therefore apply to the above-mentioned categories. Companies with same director or parent company or substitute Company can submit the bid through single/as one entity only, multiple bids not allowed.

### 11. EOI Preparation Cost

The Applicant is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in conduct of informative and other diligence activities, participation in meetings/ discussions/ presentations, preparation of its application, in providing any additional information required by the authority to facilitate the Application process. The authority will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process. All materials submitted by the Applicant shall become the property of the authority and may be returned at its sole discretion. No Applicant shall submit more than one EOI.

### 12. Amendment

The Authority may modify the EOI by issuing an addendum / corrigendum before the last date of submission of the Application. Any addendum / corrigendum issued shall be part of EOI and shall be posted on AMC's websites.



To give Applicants reasonable time in which to take addendum / corrigendum into account in preparing their applications, the authority may at its sole discretion, extend the last date of submission of application.

### **13. Language**

The EOI application prepared by the Applicant and all correspondence and documents related to the EOI, and exchange by the Applicant and the authority shall be written in English. Any printed literature furnished by the Applicant may be written in another language if such literature is accompanied by a translation of its pertinent passages in English, in which case, for purpose of interpretation of the EOI, the English translation shall govern.

### **14. Documents to be Submitted**

The Application shall include the following requisite documents and necessary supporting documents as specified in Forms No. 1 to 7:

### **15. Submission of Application**

- The duly filled application forms along with required/ supporting documents as per the EOI document, signed and stamped by the Authorized Signatory shall constitute the Application. The Application must be supported with documentary evidence wherever necessary.
- The Application shall be of A4 size and must be submitted in hard copy as a spiral/ hard bound document. Along with a hard copy, a soft copy in PDF format shall also be submitted through mail address.
- The Application shall be submitted in a sealed envelope indicating the name, address, and contact phone number of the Applicant.
- The sealed envelope shall clearly bear the following identification,

### **16. Right to Accept/ Reject an EOI**

- The Authority may cancel the EOI at any stage without assigning any reasons whatsoever and will not be liable to compensate any participant on any grounds whatsoever.
