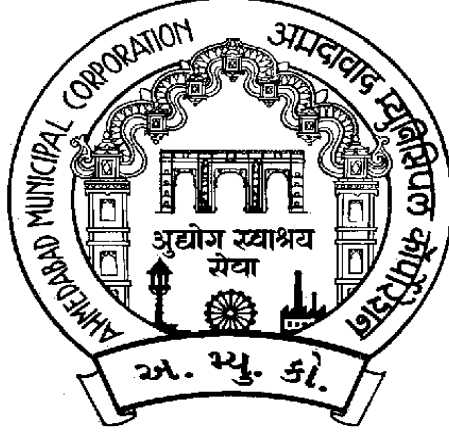

# INTRODUCTION

---

## 1 PROJECT BACKGROUND

Kankaria Lake has a unique identity in Ahmedabad. The historic lake around Nagina wadi has been an evergreen outing place for the people of Ahmedabad. As a result of the redevelopment of Kankaria Lake Front, a city-level spot was converted into a state-level recreational zone through a planned approach.

Kankaria Lake Front provides opportunities to launch city-level and state-level events that bring participation from all communities and strata. Its development with facilities like **Atal & Swarnim Jayanti Express-Toy Trains**, Kids City, Amusement Parks, Segway Safari, Adventure Tree Walk, Aqua Carting, Aquarium, Multi Colour Laser Shows with Musical Fountains, Food Courts, Walkways, Linear Gardens & Landscapes has added new charms for the visitors.

The Atal Express and Swarnim Jayanti Express are two popular toy trains that operates at Kankaria Lake Front in Ahmedabad, Gujarat. These trains offer a fun and scenic way to explore the beautiful lake and its surrounding attractions. Atal & swarnim Jayanti Express were bought in 2008 and 2010 respectively has been running since. The capacity of the trains is 144 passengers each. The trains serve 7 – 8 lakh visitors every year, takes about 20 minutes to circle the lake for a distance of 2.2 Km.

The trains have completed 15 years, and the lifespan of the same is over. Thus, AMC has bought 2 toy trains for Kankaria Lake Front and through this RFP is inviting the interested parties to salvage the existing trains and supply new trains at Kankaria, Ahmedabad, Gujarat. AMC has already upgraded the tracks in 2022 at a cost of ~3.5 Crore, thus only the new trains are to be bought.

## 2 PURPOSE OF INVITING EOI

Ahmedabad Municipal Corporation, Ahmedabad, Gujarat is desirous to Selection of an Agency for the Procurement of two new toy trains for Kankaria Lake Front, Kankaria. Under this format, the private sector shall be responsible for the Supply of two new toy trains and the salvaging of the two existing toy trains.

## 3 EXPECTATIONS FROM THE INTERESTED PARTIES/ AGENCIES/ COMPANIES.

- a. Salvaging of the two existing toy trains
- b. Supplying of the two new toy trains having a diesel engine.
- c. The toy train design shall be aesthetically in line with the theme of Kankaria Lake.
- d. Installation of the two new toy trains.
- e. Testing and commissioning of the new toy trains.
- f. Providing a warranty period for the new toy trains which shall include regular repairs and parts replacement.
- g. Provision of operational plan for the new toy trains.

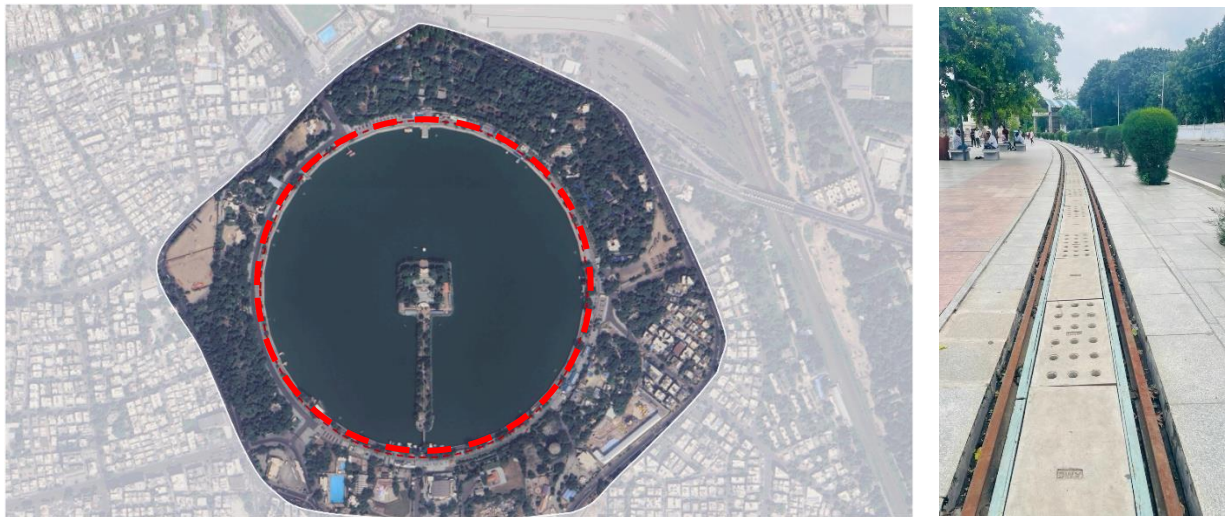
- h. The service provider shall provide all necessary documents such as safety certificates, manuals etc.

*Note: AMC has already upgraded the tracks in 2022. Thus, the proposed train will run on the same tracks.*

## **6 GENERAL INSTRUCTION TO BIDDERS**

- A. The cost of Bid document i.e. EOI fees will not be refunded under any circumstances.
- B. Language of the bid shall be English only.
- C. The Bidder should provide the details of the proposed trains pt to the authority.
- D. Bidders are advised to visit the site to study the actual working conditions, before submitting the EOI.
- E. Bidders shall submit necessary registration certificates any other if required for the execution of such work as per government rules along with the tender document.
- F. If required bidders may visit Kankaria Lake Front Department, Vyamshala Gate no. 3, Maninagar, Ahmedabad for further clarification.
- G. Conditional EOI shall not be accepted. Authority reserves the right to accept or reject such EOIs without assigning any reason thereof.
- H. In case of any dispute or difference of opinion in the interpretation of any of the terms and conditions of this EOI, the decision of the Municipal Commissioner, shall be final and binding to all.
- I. If the EOI is cancelled no cost will be paid in any circumstances.
- J. The courts at Ahmedabad in Gujarat state only will have jurisdiction to deal with and decide any legal dispute or contravention between the parties hereto.

# EVALUATION CRITERIA

---

- a. The Applicants' competence and capability is proposed to be evaluated by the following parameters.
  - Financial Capability in terms of Net-Worth & Annual Turnover and
  - Technical Capability of the Applicant.
- b. On each of these parameters, the Applicant would be required to meet the evaluation criteria as detailed in this section.
- c. The Applicant fulfilling the following conditions will be eligible to apply for this EOI.

## 7 FINANCIAL CAPACITY

### EOI submitting for New Toy Trains;

- The Bidder must have an annual audited average turnover of at least INR 60,00,000 (Sixty Lakhs only) from supplying toy trains for any three (3) years from the past five (5) years. (2019-2020, 2020-2021, 2021-2022, 2022-2023, 2023-2024)

*Note: In consideration of the Covid-19 pandemic, the turnover of FY 2020-21 will not be considered, though needs to be submitted.*

And

- The Applicant should have a positive net worth for FY 2023-24. The applicant should submit proof of net worth for the FY 2023-24.

## 8 TECHNICAL CAPACITY

The Applicant should have the following minimum experience mentioned below:

### EOI submitting for New Toy Trains;

- i. The Bidder must provide a minimum of 2 relevant certificates/proof of supplying of toy train with a minimum capacity of 70+ passengers in the past ten years from the date of issue of this EOI.  
and
- ii. As part of Technical Capacity, applicants are expected to make a presentation to the authority based on the concept note submitted (*Refer to Form 4*).

*Note: The presentation will be of 100 marks, wherein 70 will be cutoff marks for qualifying in this EOI.*

## 9 SHORTLISTING OF THE APPLICANTS & ISSUE OF RFP

- The applicants meeting the requirements as detailed above, including the presentation made to the satisfaction of the authority shall be shortlisted for further selection process. The authority reserves the right to disqualify any bidder at this stage, if the presentations made is not as per

the expectation of the Authority. The decision of the municipal commissioner shall be final and binding for each participant for this EOI.

- The Request for Proposal (RFP) document will be limited to the applicants filling the EOI (Closed Bid). If as per the authority's opinion, none of the submitted EOI is up to the mark, the Authority reserves the right to go for open tender.
- Minimum two (2) EOIs shall be received for the issue of the RFP.
- AMC will release either;
  - The Request for Proposal (RFP) for the procurement of the two toy trains for Kankaria Lake Front.

**OR**

- The Request for Proposal (RFP) for the procurement and, operation & maintenance of two toy trains for Kankaria Lake Front. (In this case JV will be permitted between the supplier and the operating agency.)
- AMC reserves the right to reject any or all EOIs received without assigning any reasons thereof.

# PREPARATION & SUBMISSION OF EOI

---

## 10 GENERAL

JV/Consortium is permitted.

- The maximum number of JV partners allowed is (one).
- International Companies are allowed for JV.
- If International Companies are bidding, then they will be required to do JV with Indian Companies.
- The Indian partner shall have a minimum share of 51% in the JV or Consortium.
- No Exit will be allowed, all the consortium partners will be responsible for the whole project.
- A Joint Venture (JV) or Consortium can only be formed between:
  - The train supplier.
  - A supplier based in India, if the train manufacturer is not from India.

For financial evaluation, the percentage share of each partner in the Joint Venture (JV) or Consortium will be used to determine their respective shares in the average annual turnover. For instance, if a JV has two partners with a 60% and 40% share, their shares in the average annual turnover will be allocated accordingly. However, for technical evaluation, the experience of all partners will be considered collectively.

The Applicant shall be legally competent to enter into an agreement as per prevailing Indian law and must be either:

- (i) A registered proprietary firm (Copy of GST registration, EPF registration, shop registration certificate, as may be applicable, should be submitted).

Or
- (ii) Partnership firm registered the Indian Partnership Act (copy of registered partnership deed should be submitted)

Or
- (iii) Limited liability partnership duly incorporated under the Limited Liability Partnership Act, 2008 (copy of registered partnership deed should be submitted)

Or
- (iv) A company incorporated under the Companies Act 1956 (as amended or re-enacted and restated including the Companies Act 2013 as notified from time to time), (Copy of certificate of incorporation, Memorandum and Article of the Association of the Applicant should be submitted)

The term applicant/bidder/service provider/operator used in the EOI document would therefore apply to the above-mentioned categories. Companies with the same director or parent company or substitute Company can submit the bid through single/as one entity only, multiple bids are not allowed.

## **11 EOI PREPARATION COST**

The Applicant is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in the conduct of informative and other diligence activities, participation in meetings/ discussions/ presentations, preparation of its application, in providing any additional information required by the authority to facilitate the Application process. The authority will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process. All materials submitted by the Applicant shall become the property of the authority and may be returned at its sole discretion. No Applicant shall submit more than one EOI.

## **12 AMENDMENT**

The Authority may modify the EOI by issuing an addendum/corrigendum before the last date of submission of the Application. Any addendum/corrigendum issued shall be part of EOI and shall be posted on AMC's websites.

To give Applicants reasonable time in which to take addendum/corrigendum into account in preparing their applications, the authority may at its sole discretion, extend the last date of submission of application.

## **13 LANGUAGE**

The EOI application prepared by the Applicant and all correspondence and documents related to the EOI, and exchange by the Applicant and the authority shall be written in English. Any printed literature furnished by the Applicant may be written in another language if such literature is accompanied by a translation of its pertinent passages in English, in which case, for the purpose of interpretation of the EOI, the English translation shall govern.

## **15 SUBMISSION OF APPLICATION**

- The duly filled application forms along with required/ supporting documents as per the EOI document, signed and stamped by the Authorized Signatory shall constitute the Application. The Application must be supported with documentary evidence wherever necessary.
- The Application shall be of A4 size and must be submitted in hard copy as a spiral/hardbound document. Along with a hard copy, a soft copy in PDF format shall also be submitted to <http://tender.nprocure.com>.
- The Application shall be submitted in a sealed envelope indicating the name, address, and contact phone number of the Applicant.
- The sealed envelope shall clearly bear the following identification,

- The participant shall not be entitled to a refund of the cost of documents or other costs in case the EOI is cancelled for whatsoever reason or without assigning any reason, at any stage.
